RULES

- 1.** The camping areas are allocated by the Management; each following transfer must Be authorized. The parking place rate does not allow to place the vehicle next to the Camping area. The above mentioned rate does not assure the placement of the vehicle in the shadow.
- 2.** The rates are to be intended per overnight stay. The following day will be charged extra (apart from the arrival time) to the guests who will leave after 2:00 p.m..
- 3.** During the period D, in case of absence from the camp, continuing to occupy the pitch, you pay only the cost of the pitch. In the period, and in case of absence from the camp, continuing to occupy the pitch, you pay the same as two people, even if only one person staying there.
- 4.** If you occupy one camping area you may park only one car, second car 4 € a day or more during the period D and E.
- 5.** Departure must be notified by guests at least one day before.
- 6.** It is absolutely forbidden:
 - to light the fire on the camping area, on the beach and in all open and tree-lined areas;
 - to damage plants, flowers and the equipment of the village;
 - to make a noise which can disturb the neighbours from 12,00 p.m. to 8,00 a.m. and from 2,00 p.m. to 4,00 p.m.;
 - to drive a vehicle into the Campsite in the hours of silence (from 12,00 p.m. to 8,00 a.m. and from 2,00 p.m. to 4,00 p.m.). In case guests do not respect the last two points of the present regulations, they will be immediately expelled from the campsite.
- 7.** Guests are responsible for their own property. The Management may not be held liable in case of missing items, thefts or for unattended valuables.
- 8.** The Management is civilly liable for a third party and for damages to people and things only in accordance to the provisions of the insurance company with which the campsite has contracted a policy as displayed at the Reception. In accordance with the provisions of all international conventions, the Management is not liable for damages to cars, since these damages are already covered by the compulsory insurance of each vehicle.

9. You are heartily required:

- to keep WC, washbasins and toilets extremely clean;
- to accompany children under 5 to the toilets;
- not to wash dishes, clothes or anything else in the washbasins for personal cleanliness;
- not to waste water and not to wash cars, caravans, rubber-dinghies or anything else;
- to throw papers and rubbish into the proper bins; guests are particularly required not to leave glass bottles nor injurious objects on the beach.

Minors are admitted if accompanied by parents or relatives.

Children must be accompanied in the use of various equipment and toilets. Parents are always directly responsible for their children. Children must be supervised by their parents and, in this regard the management declines all responsibility.

The Management takes great care of the toilets' cleanness, but this is not enough without any collaboration ;

guests may not only complain to the Management. Each guest is required to intervene or to let the campsite staff intervene at the right moment, in case these basic rules of behaviour and hygiene are not respected .

10. Relatives, friends and visitors in general are admitted to the Campsite only after Being authorized by the Management and after leaving an ID document and paying a visitor's daily charge. The Management reserves the right to check at any time the identity of the visitors inside the campsite.

THE MANAGEMENT
